1.1 Entries at office (**TOGETHER WITH SELLER'S CERTIFICATION AND INDEMNITY**) and also **FINAL** closing date (no amendments after this date): **6 WEEKS BEFORE**  
**Any amendments hereafter shall be done @ R250.00 per amendment.**

1.2 **Sale pamphlet** for approval – see 7.1: **6 WEEKS BEFORE**  
If sale pamphlet is not received along with entries, the pamphlet will not be placed on the web, since the information on the pamphlet and catalogue may differ.

**No Sale pamphlet will be approved without the sale entries.**

1.3 Confirmation in writing of notification and receipt of sale rules: **6 WEEKS BEFORE**

1.4 Sale location (e.g. Farm Goedehoop District Bethulie):

1.5 Final master catalogue from office to auctioneer for duplication: **2 WEEKS BEFORE**

1.6 Catalogue/pamphlet at [www.simmentaler.org](http://www.simmentaler.org) or [www.simbra.org](http://www.simbra.org): **4 WEEKS BEFORE**

## 2. INDEMNITY

2.1 The Council and staff of the Simmentaler/Simbra Cattle Breeders' Society are indemnified against any claims of buyers (as per vendu roll) or sellers that may result from sales on this sale.

2.2 The Simmentaler/Simbra Cattle Breeders' Society are indemnified against any damage that we or any third party may sustain as a result of unsafe or defective products supplied by them.

## 3. REQUIREMENTS FOR OFFER

3.1 Refer to pages 4, 5, 6, 7 & 8 for compulsory requirements regarding ear tattooing, semen, fertility and pregnancy certification, trichomoniasis and vibriosis and TB/BM.

3.2 Refer to pages 4, 5, 6, 7 & 8 for Simmentaler and Simbra Sale rules.

3.3 Simmentaler and Simbra bulls without a birth weight breeding value\* may be offered, but do not qualify as under the auspices of the Society. \* = Breeding values at the time of publication of catalogue.

3.4 An open heifer of a bull-heifer twin may not be offered.

3.5 All sires of calves not on record at the Society, and service sires of pregnant cows, as well as semen, may only be offered at a sale with a DNA certificate/report and shall be screened.

3.6 The offer shall be approved on appearance by a Technical Advisor or judge. Previously approved-for-registration animals may be disapproved for the sale. **NOT APPLICABLE TO SALES FOR NATIONAL CHAMPIONSHIPS.**

3.7 **Auxiliary studbook A (Simmentaler)** female animals may be offered, but may not be more than 10% of the sale offer, unless they meet the following requirements: (a) Had at least two calvings after registration, and (b) within twelve months after each calving have again been confirmed/certified to be pregnant; (c) **Auxiliary studbook A female animals** not meeting these requirements may still be sold as part of the 10% rule, see also clauses 3.2 and 3.3 above, which include animals that do not comply with the Simmentaler sale rules.

3.8 **TOTAL DISPERSALS - CONTACT OFFICE.**

#### 4. **LIABILITIES OF SELLER**

- 4.1 Attached "SELLER'S CERTIFICATION" (ref CERT), properly signed, shall be submitted **TOGETHER WITH** enclosed entry form.
- 4.2 The latest **birth notifications** shall be supplied along with the attached sale forms before date in accordance with 1.1, for inclusion in the catalogue. If not, the calvings will not be calculated.
- 4.3 Seller and guest sellers will jointly be liable for all sale costs.
- 4.4 Foreign sales – Seller remains liable for animals sold to foreign buyers, until the necessary tests have been done and completed.

#### 5. **FALSE OFFER**

All animals that are advertised and approved by the Technical Advisor shall be offered, provided that withdrawals are possible only by means of veterinary certification. Such certification shall be provided to the office or Technical Advisor before the sale.

#### 6. **LIABILITIES OF AUCTIONEER**

- 6.1 If the sale meets the requirements of the Simmentaler/Simbra Sale rules, the sale pamphlet shall be submitted to the Society for approval **before** publication. If sale pamphlet is not received along with entries, the pamphlet will not be placed on the web page, since the information on the pamphlet and catalogue may differ.  
**No pamphlet will be approved without the offer/sale entries.**
- 6.2 The wording "**PERFORMANCE RECORDS, PEDIGREES, PHOTOS AND MORE AT [www.simmentaler.org](http://www.simmentaler.org) or [www.simbra.org](http://www.simbra.org)**" (select relevant breed) shall appear in large and clear letters on the pamphlet and advertisements.
- 6.3 The rules on the next page (REF CATAL) shall be published in the front of the catalogue.
- 6.4 Advertising as "Sale Under the Auspices of the Society" with the official breed emblem may only be used for Simmentaler and Simbra sales that are conducted "Under the Auspices of the Society".
- 6.5 **Photos** of animals offered "not under the auspices" – a "**NOT UNDER THE RULES**" note shall be clearly affixed to the photo or in the comments.
- 6.6 **The Auctioneer shall check the tattooing of the animals being offered; it should correspond with the certificates, and the tattooing shall be checked during lot numbering – ear tags should not be relied upon, since it may differ from the tattoo.**
- 6.7 Written confirmation of **receipt of the sale rules and abiding by them**, should please provided by the auctioneer, **before the deadline for providing the master catalogue.**
- 6.8 The following shall be provided to the Society within **seven working days after the sale**: (i) sale catalogue; (ii) buyers' list/vendu roll with e-mail addresses of buyers (iii) certificates with service details or servicing list (iv) bulls' fertility certificates and (v) sale summary.

### **SIMMENTALER SALE RULES**

1. When signing these sale rules, the seller has to submit written proof that his sale animals tested clean of TB and BM within 60 days before the sale, or submit a CA3 certificate/veterinary certificate specifying that all his animals tested clean in the past twelve months. **No sales will be accepted without these certificates.**
2. Animals older than one year (on day of sale) will be presented as a registered animal in the catalogue and the registration certificate will be transferred to the buyer at the seller's expense.
3. Animals under 1 year\* are recorded as calf book and their official calf book certificate will be transferred to the buyer at the seller's expense. Members of the Society can offer these animals between the ages of 1 and 3 years for full registration in the Herd Book.
4. The seller has signed and submitted the following "Seller's Certification":
  - 4.1 that the animals offered have been tattooed and checked and that it corresponds with the certificates. If the buyer can prove within 30 days after the sale that the animal was not tattooed or was incorrectly tattooed, guarantee 6 will apply.
  - 4.2 that all bulls older than 365 days\* (i) have been certified as fertile by a veterinarian OR (ii) the bulls' semen has been certified as fertile by a registered veterinary technologist, no more than 30 days before the sale. **Motility, morphology and scrotal circumference shall be evaluated and specified on the prescribed evaluation report (see p. 9)** and that is is guaranteed by the seller up to 7 calendar days after the date of sale. Fertility certification shall be available on request from the seller for up to 1 year after the date of sale. If the buyer can present a veterinary certificate that proves the contrary within 7 days after the sale, guarantee 6 will apply.
  - 4.3 any guarantees concerning the freezing of semen shall be made by a separate agreement between the buyer and seller.
  - 4.4 that all bulls tested clean of trichomoniasis en vibriosis.
  - 4.5 that all sires of calves not on record at the Society, and service sires of pregnant cows, as well as semen, have a DNA certificate/report on record that the bulls have been screened.
  - 4.6 that the following animals presented as pregnant **have been certified as pregnant by a veterinarian** and such certification is available on request from the seller for up to 1 year after the date of sale provided that such animals presented comply with the Simmentaler sale rules:
    - heifers 28 months and older\* – also see item 7 (iv);
    - cows within 12 months (365 days)\* after last calving on record; and
    - all other female animals advertised as pregnant in the sale catalogue or any enclosures thereto.
    - Egg donors – Simdex requirements are not applicable. Must be pregnant within 12 months since last flush date or date of birth of own calf.
    - Receptor animals – Simdex requirements are applicable. Must be pregnant within 12 months since last embryo calf or date of birth of own calf.
  - 4.7 If such animals that have been certified pregnant are certified as not pregnant by a veterinarian within 48 hours after the sale, guarantee 6 will apply.
5. If a female animal is sold as "open" or "not pregnant" and is certified pregnant by a veterinarian within 30 days after the sale, guarantee 6 will apply.
6. If the necessary proof is provided to the seller in writing within the relevant period, the seller shall, at the choice of the buyer, replace any animal as described above under 4.1, 4.2, 4.4, 4.5 and 5, with other animals of equal value or refund the purchase price.
7. Animals offered shall meet with the following requirements:
  - (i) refer 2 and 3; (ii) minimum Simdex reproduction index at last calving of 80 (cows with 1 calf) or 85 (cows with two or more calves) (iii) Simmentaler bulls shall have a birth weight breeding value at the time of the compilation of catalogue; (iv) maximum predicted age of heifers with 1<sup>st</sup> calving no higher than 36 months (1 095 days\*); (v) **Auxiliary studbook A** female animals may be offered, provided they meet the following requirements: (a) At least two calvings after registration, and (b) within twelve months after each calving have again been confirmed/certified to be pregnant; (c) **Auxiliary studbook A female animals** not meeting these requirements may still be sold as part of the 10% rule, which includes animals that do not comply with the Simmentaler sale rules.

  - 7.2 cows within 12 months (365 days\*) after each calving on record; and
  - 7.3 all other female animals advertised as pregnant in the sale catalogue or any enclosures thereto.
  - 7.4 (ii) Egg donors – Simdex requirements are not applicable, but are pregnant within 12 months since last flush date or date of birth of own calf.  
(ii) Receptor animals – Simdex requirements are applicable and are pregnant within 12 months since last embryo calf or date of birth of own calf.
- 7.5 **Auxiliary studbook A** female animals offered shall meet the following requirements:
  - (a) at least two calvings after registration, and (b) within twelve months after each calving have again been confirmed/certified to be pregnant; (c) **Auxiliary studbook A female animals** not meeting these requirements may still be sold as part of the 10% rule, which includes animals that do not comply with the Simmentaler sale rules.
- 7.6 that if such animals that have been certified pregnant are certified as not pregnant by a veterinarian within 48 hours after the sale, guarantee 9 will apply.

### **SIMBRA SALE RULES**

When signing these sale rules, the seller has to provide written proof that his herd has tested clean of BM within the previous 12 months and within the previous 24 months tested clean for TB.

NO SALE ANIMALS WILL BE ACCEPTED WITHOUT these certificates.

### **REGISTERED SIMBRAS**

1. Screened animals older than 12 months (on date of sale) will be presented in the catalogue as a registered animal and the registration certificate will be transferred to the name of the buyer at the expense of the seller.
2. Animals under 12 months\* are recorded in the calf book register and their calf book certificate will be transferred to the buyer at the seller's expense. Members of the Society can offer these animals between the ages of 1 and 3 years for screening after which a registration certificate will be issued to him.
3. The seller has signed and submitted the following "Seller's Certification":
  - 3.1 that the animals offered have been tattooed and checked and that it corresponds with the details on the registration certificate. If the buyer can prove within 7 (seven) days after the sale that the animal was not tattooed or was incorrectly tattooed, guarantee 6 will apply.
  - 3.2 that all screened bulls offered have been examined by either a veterinarian or a registered veterinary technologist no more than 30 days before the sale and that semen was collected from such bulls and that it meets ALL requirements with regard to fertility. Scrotal circumference shall also be measured and a fertility certificate with all relevant information shall be issued to the seller. Such fertility certificate shall be kept by the seller for a minimum of 1 (one) year after date of sale and shall be made available to the buyer at any time. If the buyer can present a veterinary certificate that proves the contrary within 7 (seven) days after date of sale, guarantee 6 will apply.
  - 3.3 that all bulls older than 3 (three) years on date of sale, have tested clean of trichomoniasis en vibriosis.
  - 3.4. that all sires of calves not on record at the Society, as well as service sires of pregnant cows at the sale, have a DNA certificate/report on record. This also applies to semen.
  - 3.5 any guarantees concerning the freezing of semen shall be made by a separate agreement between the buyer and seller.
  - 3.6 All female animals offered as pregnant, shall be certified as pregnant by a veterinarian or veterinary technologist and such certificate shall be kept by the seller for at least 1 year and shall be made available to the buyer at any time. If the buyer produces a veterinary certificate that proves that the cow he bought is not pregnant within 7 days of sale, guarantee 6 shall apply.
  - 3.7 A cow without a calf at foot shall be certified as pregnant and the expected calving date may not be later than 18 months since her last calving and such a cow may not have been "open" for longer than 18 months between 2 calvings.

- 3.8 A pregnant heifer offered shall calf before or at 33 months.
- 3.9 Open heifers may only be offered up to 24 months of age on day of sale.
- 3.10 Egg donors must be pregnant within 18 months since last flush date or date of birth of own calf.
- 3.11 Receptor cows must be pregnant within 18 months since last embryo calf or date of birth of own calf.
- 3.12 All bulls offered should have a birth weight breeding value at the time of the compilation of the catalogue.

**F1 "CUM" COWS**

An F1 "CUM" cow shall have had at least two calves since being screened, and if she is without a calf at foot, she should be certified as pregnant and such calving date may not be later than 18 months since her last calving AND she may also not have been "open" for longer than 18 months between two calvings.

A minimum of 90% of the offer of above-mentioned shall comply with the sale rules.

**COMMERCIAL COWS (SIMBRA TYPE)**

(Law provides that no unregistered animal may be sold without such animal having the owner's brand. Tattooing not necessary.)

Such cows shall be at least 3/1 or have a young calf with her or be certified as pregnant.

- 4. If an animal is sold as "open" or "not pregnant" and the animal is certified pregnant by a veterinarian within 30 days after the sale, guarantee 6 will apply.
- 5. If an animal that has been sold as pregnant and she is certified as not pregnant by a veterinarian within 48 hours after the sale, guarantee 6 will apply.
- 6. If the necessary proof is provided to the seller within the relevant period, the seller shall, at the choice of the buyer, replace any animal as described above under 3.1, 3.2, 3.6, 4 and 5, with another animal of equal value or refund the purchase price and take possession of the sold animal again.

Fertility certification shall be available on request from the seller for up to 1 year after the date of sale. If the buyer can present a veterinary certificate that proves the contrary within 7 days after the sale, guarantee 9 will apply.
