5. Simbra Feedback (Kobus Bester)

Simbra is a value proposition underpinned by Animal Science. Efficient staff and continual breeder development enable us to equip our breeders to improve and develop into successful seedstock producers. During the course of the year a number of different milestones were reached with special mention to the following:

- Development of a Simbra Inspectors and Judges Manual
- Development of a Simbra Breeders Manual
- Establishment of New Regional Clubs
 - Free State Club chaired by Andre van Wyk
 - Mpumalanga Club chaired by Arne Grobbelaar
 - Limpopo Club chaired by Kobus Badenhorst

- A total of 17 farmers days and training days were attended
- Implementation of the Linear Classification System
- Implementation of SNP Genotyping

6. Financial Reporting (Kobus Bester)

In accordance with the Simbra Constitution the financial position was discussed. The financial position of the Society as at 31 August 2022:

- Bank balance R1 256 458.24
- Debtors: R485 013.04 outstanding, of which R377 988.15 is 120 days and older. Kobus Bester thanks those Simbra breeders for the prompt payment of their accounts and calls on members owing to make their payments as soon as possible.
- The Society budget a loss of R343 709.88 for this financial year. Mainly attributable to the legal cost incurred of R789 897.65.
- The average herd size of 240 animals , comprises of 51 calfbook males, 71 calfbook females, 110 registered females and 8 registered bulls and amounts to a total of R18 768.32 in membership fees. This could be covered by the sale of three weaners, re-iterating the fact that stud breeding can be profitable.

The Income Budget for 2023 was presented and Mr Kobus Bester advised the meeting to consider a 10% increase in fees. The Expenses budget was presented with special notice given to increased expenses for Breed Improvement Services, Salaries and Wages, Rentals, and Travel. Legal Expenses were also discussed, the expense has been incurred and paid for and a further budget of R100 000 for this year and R40 000 for nex year should be sufficient to finalise the matter. A query was raised about the increase in Breed Improvement Services, Mr Kobus Bester continued to share a powerful statement: "Die genootskap se focus is om ons bestaande en veral ons jong telers kern gesond van binne na buite te help groei en ontwikkel". He then went on to explain that the increase was primarily due to a plan to equip, develop and improve breeders success through the hosting of new breeder induction courses, training days and the Simbra Academy. A request was made to host the Simbra Academy in February 2023 – this will be further investigated and available dates will be discussed with the staff at the Afridome. Mr Kobus Bester requested the meeting to consider the approving the budget as presented and explained.

7. Breed Statistics (Kobus Bester)

Attention was drawn to an increase in the number of inspections from 4041 to 4253 since 2019. There was a total of 22 active inspectors in the last year. A panel of available inspectors has been established and published on the website. Accreditation of these inspectors is awarded according to knowledge on phenotypic and genotypic selection and inspectors are assessed on a non-biased system and refresher courses are to be held annually. Current member and animal numbers were disclosed.

8. BIC Feedback (Matthew Kinghorn)

Feedback was provided on the transition to Breedplan Software Version 6.2 and the implementation of the Simbra Selection Indexes which is expected to take place before the end of the year. The changeover to version 6.2 of Breedplan will also mean that we will be obtaining EBVs for Net Feed Intake. A total of 45 batches (472 samples) of SNPs were sent on the special offer to Neogen. This amounts to approximately 800 samples on the system, taking us a little bit closer to our target of 2000 SNPs and towards genomically enhanced breeding values (GEBVs). GEBVs are a powerful driver of genetic progress and are expected to increase the accuracies of difficult to measure traits such as Fertility, Carcass and Net Feed Intake traits.

9. Breed Standards (Kobus Bester)

The floor was opened for the discussion of a number of points relating to breed standards.

Eye Pigmentation

A question was raised by our Namibian breeders and by the Eastern Cape club around the downgrading of females with less than 50% eye pigmentation. At the keurdersaamtrek in April 2021 it was decided that females did not need to be downgraded in the herdbook for pigmentation. Three proposals were put forward:

1) Females should not be downgraded in the herdbook if they have less than 50% eye pigmentation (Jaco Mare)

- 2) Females should be downgraded in the herdbook if they have less than 50% eye pigmentation (Rick Dell)
- 3) Both males and females should be treated in the same manner. A minimum of 50% pigmentation should be implemented in both sexes. (Eugene Marais)

The above proposals were put to a vote, and Option 1 won the vote with 11 votes in favour. Therefore, it was decided that females do not need to be downgraded in the herdbook if they have less than 50% eye pigmentation. It was re-iterated that the requirements for eye-pigmentation of males is to remain unchanged.

Inspections

A question was raised as to whether inspections should be compulsory for registrations. Some breeders perform their own inspections, and when it comes to society inspections no animals are rejected. They felt they were not receiving value for money in this regard. The matter was discussed, and the meeting felt that inspections should still be a pre-requisite for registration and should be done by an independent inspector.

Nobody seconded this proposal, and the current inspection system remains in place.

A proposal was put forward by Mr Kobus Bester, that on the date that the annual levy lists are sent out to the breeders, all male or female calfbook animals that are 24 months or older will be billed at the same per capita fee as registered animals. It is the breeder's responsibility to ensure that inspections remain up to date.

• Protocol for handling genetic defects

The LRF has put a request through on behalf of the societies to make genetic condition results available in the public domain (i.e., Internet Solutions). We are awaiting a response to confirm a timeline. For the time being Kobus Bester put forward a proposal that the society disclose this information.

Unanimously accepted.

It was proposed that the following two points be added to the constitution.

- 1) The Society maintains the right to rectify pedigrees corrected by means of SNP parentage or any improved future technologies
- 2) The Society should be allowed to request a SNP genetic condition test for any animal

There was no opposition to these proposals, and they will be further discussed and voted upon at the Annual General Meeting in 2023.

Auction Rules

Attention was drawn to a new timeline of 6 weeks before the auction wherein all administration information should be submitted to the office (i.e., lot forms, comments, weights and DNA etc.) A proposal was put forward to have one person, the Breed Director, to perform or be present at all Auction Screenings to ensure that Breed Standards are consequently being upheld. This proposal was then amended, and it was suggested that a panel of three senior/accredited inspectors should be able to assist with auction screenings, whereby one of them should be the Breed Director.

• Fertility test period of bulls prior to the auction date

The current auction rules require that the bull's fertility test should be done within 30 days of the auction. There was a request to extend this period. A period of 45 days was voted upon and approved. The Sale Rules will be subsequently updated.

10. Club Feedback (Kobus Bester)

A meeting was held with club representatives in August. Based on feedback from this meeting, the following areas needed additional focus.

- Need for training of stud breeders
- Need for training of commercial farmers
- Would like to see improved bull retention
- Need for structurally sound bulls in the R40 000 R60 000 price range.
- Need for AI bulls
- Program to help breeders reach success
 - $\circ \quad \ \ \text{Induction course for new breeders}$
 - Simbra Academy/School
 - Continual Professional Development (Breeder development)
- Emphasis on genotypic as well as phenotypic selection, with practical exercises in the kraal.
- 11. Member Feedback (Kobus Bester)

Of the 20 auctions held in the last year 408 bulls were offered, of which 367 bulls sold. Resulting in a turnover of R27 306 287 where the average bull price was R74 406

12. Simmentaler Simbra Legal Dispute Feedback (Tito Vorster)

A settlement agreement between Simmentaler and Simbra has not yet been reached. Our advocate fees have been capped to limit the expenses beyond what has been budgeted for. If a settlement cannot be reached, we expect the case to be heard in the Supreme Court of Appeal in the first quarter of 2023.






